



Junior Academy General Policies

- It is a condition of participation that when a junior golfer signs up with Peak Performance Golf Junior Academy, they are bound by the fees and policies set forth by Peak Performance Golf. Payment of fees indicates acceptance of all fees and policies.
- A one time \$60.00 registration and processing fee is due at the time the application is turned in for registration of junior. This fee is non-refundable.
- Participation in the Peak Performance Golf Junior Academy will not be confirmed until the monthly financial obligation has been met and the waiver of liability form has been signed and returned.
- In the event that a junior must cancel, fees will be refunded in full if the junior has not participated in any training session during the current month. If the junior golfer has participated in at least one training session during the month, no fees will be refunded.
- Greg Coffin Enterprises Inc. accepts no liability whatsoever in relation to any accident, injuries, death, loss or any other damage caused to or by the junior golfer who is a participant of the Peak Performance Golf Junior Academy.

Participants Code of Conduct

Peak Performance Golf requires all participants to act in a professional manner at all times both on and off the golf course. Proper golf etiquette is mandatory.

Peak Performance Golf reserves the right to suspend or disqualify any individual who breaches the code of conduct regulations with no refund of fees paid.

Dress Code

Peak Performance Golf requires its participants to dress with appropriate golfing attire. Shorts are permitted and are recommended. All participants must wear a golf shirt with a collar. Footwear must be golf or running shoes. Golf shoes must not have metal spikes.

Inclement Weather Policy

In the unlikely event of rain or other inclement weather, Peak Performance Golf will do its best to reschedule the training session; this is based on the availability of the host facility. Peak Performance Golf accepts no responsibility if the training session is unable to be rescheduled. Fees are non-refundable due to inclement weather.





Peak Performance Golf Junior Academy

Peak Performance Golf Junior Academy is a unique training experience for developing today's junior golfer. The junior academy focuses on long term development so that the junior golfer will realize their individual potential.

Peak Performance Golf agrees to provide the junior with training sessions in the sport of golf on a scheduled basis established by Peak Performance Golf. Each training session will run between sixty and ninety minutes in duration.

The training scheduled may be modified at the discretion of Peak Performance Golf from time to time for the holidays, tournaments and other academy activities. Peak Performance Golf shall give prior notice of such modifications by general announcement and/or posted on its website www.peakperformancegolf.us under the heading calendar of events.

Without prior written request from the student, and without prior written approval of Peak Performance Golf, no deviation of the established training session schedule may be made by the student, and the failure of the student to attend any scheduled training session shall terminate his or her rights to that session only.

The student recognizes that regular attendance is important for the student's progress and understands that it is the student's responsibility to attend the training sessions. It is further understood that the student is obligated to make payments whether or not the student attends the monthly sessions unless prior written notice has been made to withdraw from the monthly sessions. The student further understands that failure to complete the monthly training sessions does not relieve the student of the obligation to pay the monthly tuition in full.

The student understands further that strict observation of the rules and regulations relative to training is required for continued participation.

The student further agrees to waive any claim of damages against Greg Coffin Enterprises Inc.; that is doing business under the name Peak Performance Golf; and/or its principles or its instructors in any case resulting from the activity.

The names of the students and any photographs or motion pictures taken during the Peak Performance Golf activities may be used for promotional purposes.





The parties agree that the costs for uniforms, equipment, test fees, tournament fees, specialty camps and other Peak Performance Golf related activities are not covered by this document and remain the responsibility of the student.

Fees

Fees will be determined and quoted after we receive your initial application. Fees are subject to change at any time. However, once you have submitted your initial application your quoted monthly fee will lock in for the duration of the training schedule.

A deposit of \$60.00 per attendee is required at time of registration.
